### Hearing Aid Sales Receipt Terms and Conditions

This receipt entitles you to the hearing aid(s), \_\_\_\_\_ batteries and the initial instruction or counseling on the use and care of the hearing aid(s). The manufacturer's warranty is supplied with each aid and does not cover earmold(s) or accessories. We will assist you in obtaining any necessary adjustments, repairs, or claims under the terms of the warranty.

- The repair warranty expires on \_\_\_\_\_.
- The loss and/or damage warranty expires on \_\_\_\_\_. The loss and damage policy provides for one replacement per aid in the event of loss, damage, or theft. There is a loss and damage deductible of \$ \_\_\_\_\_ per aid.

Lost or damaged hearing aids cannot be returned for refund during this trial period.

This receipt does not include any diagnostic hearing evaluations or testing by the audiologist, any assistive listening devices and/or hearing aid related accessories, or any post-warranty checks, adjustments, or repairs on the aid(s) and/or earmold(s).
